They estimate that for every \$100 a copper thief gets for their stolen copper, it cost the utility company \$5,000 to repair. The problem is so severe that the FBI has stated, "copper thieves are threatening critical US infrastructure". Copper theft is in the news every single day nationwide. Police departments, prosecutors, businesses, local and state governments are struggling to educate their personnel quickly in an effort to prevent, investigate, and prosecute criminals who are committing this crime. Copper theft is widely known as a methamphetamine crime, and it is estimated that over 90% of suspects who steal copper do so in order to support their addiction. Yesterday's burglars have transformed into today's copper thieves.
